**Step 2**

Please enter the required information to register as follows:

- ✓ **Holding Type:** Issuer Sponsored or CHESS
- ✓ **Reference Number:** Enter your reference number leaving off any letters and the leading zeros.  
This can be found on a Holding/Interest Statement. If you require a new statement to be sent out, please contact Bendigo and Adelaide Bank Share Registry.
- ✓ **Name and Postcode:** Enter the registered name and postcode of your holding or if an overseas holder your country of residence.

Click on “**Register**”

**Step 3**

On the next screen you will be asked to create a Username then click on ‘**Create Account**’.

**Step 4**

You will then need to enter your Temporary InvestorServe Password (provided in the top right of the first page of this letter). Please note this is case sensitive.

**Step 5**

Review and ‘**Accept**’ the Terms and Conditions. On the next screen you will be asked to create a new password to use in future with your username, as well as set up security questions for future validation. Once this screen is completed you will have created your account.
