

Private Wildlife Licence Application Form

Wildlife Basic Licence

Authorises the holder to possess, keep, breed, buy, sell and dispose of any wildlife (whether alive or dead) listed in Schedules 2 & 7 of the Wildlife Regulations 2013 for non-commercial purposes.

Wildlife Advanced Licence

Authorises the holder to possess, keep, breed, buy, sell and dispose of any wildlife (whether alive or dead) listed in Schedules 2, 3 & 7 of the Wildlife Regulations 2013 for non-commercial purposes.

Wildlife Specimen Licence

Authorises the holder to possess, keep, buy, sell and dispose of prepared or mounted specimens of any dead wildlife for non-commercial purposes.

About this Application

The minimum age for applicants is 10 years of age. A licence will only be issued to a natural person.
