History of the Co-operative

The Co-operative was formed in 1918 to assist members in the export of their Apple and Pear crops and later to provide packing and cool store facilities.

Some 90 plus years later the Co-operative has seen many changes, progressing from the Cool Storage Facilities to operating several robust business outlets today with annual sales in excess of 20 million dollars.

How it operates

The Co-operative has been and is still controlled by a Board of up to 7 Directors who are elected by members to govern the business. The Board in turn employs a Chief Executive Officer to oversee the daily operation of the entire business. This process over past years has seen the redevelopment of the Co-operative into a secure solid performing business. The Board of Directors may declare a dividend or discount to members every year depending on the cash flow requirements of the business.

How to become a member

To become a member of the Co-operative is quite easy and follows a few simple steps;

1. Fill in the Application for Membership form and return to the Co-operative's office.
2. Once approval has been given by the Board of Directors and payment has been made for your shares, you will be issued with a member's card.
3. The recording of your trading begins.

The benefits to you

The amount that will be returned to you in the form of cash discount vouchers and or bonus shares depends on how much trade is conducted by you in the Co-operatives outlets over the trading year. (Note: This does not include tobacco or fuel purchases) The Co-operative currently has over 2,200 members who enjoy the benefits returned to them by way of trading discounts.

As an extra bonus to card holders when using your members card for purchases made within the Co-operative's Supa IGA Supermarket and IGA Liquor store you will be rewarded for your loyalty in the way of a rewards voucher. Currently, once \$2,500 has been spent a \$20.00 voucher is sent to you.

The voucher can be redeemed for goods at either the Co-operative's Supa IGA, IGA Liquor or Mitre 10 store. This is an added benefit to members and does not replace yearly discounts and dividends. The voucher must be signed and presented by the approved member only when redeeming for goods. Identification may be required.

Enclosed is the application form for you to complete and return to receive your Members Card and to start to enjoy the benefits of being a loyal member of the Mount Barker Co-operative.

I/We authorise you to place my name on the Register of Members of the Co-operative in respect of the shares so allotted and to deduct any amounts due to me at any time from these shares from any debit I may accrue with the Co-operative.

I/We understand that the Co-operative policy of repurchasing shares requires a period of twelve months of non-trading with the Co-operative before being eligible for consideration by the Board of Directors to repurchase shares. Shares may be repurchased at less than the paid up value. Currently they are repurchased at 60%. I/We accept these policies.

I/We agree to be bound by the rules of the Mount Barker Co-operative (MBC) for the time being in force. In the case of Joint Applicants, withdrawals must be signed by either/all persons.

I/We agree to be an active member of the Mount Barker Co-operative (MBC) and understand that as an active member, I/We must purchase goods or services to the value of \$1000 during a 3 year period. **(See over for Terms and Conditions)**

**Alternatively, I/we may apply to the Administration Department for the option of part paying for the shares at 40 cents per share. I/we acknowledge that if I/we take up this option that the MBC has the right to apply future cash entitlements owing to me/us against the amount outstanding on the shares until such time as they are fully paid up to \$2.00 per share.
